

END USER LICENSE AGREEMENT FOR THE PHOENIX UNIVERSAL COMPLIANCE MANAGEMENT SYSTEM

PLEASE READ THIS END USER LICENSE AGREEMENT (“EULA”) CAREFULLY. BY CLICKING “I AGREE” OR TAKING ANY STEP TO DOWNLOAD, SET-UP, INSTALL OR USE ALL OR ANY PORTION OF THIS PRODUCT (INCLUDING, BUT NOT LIMITED TO, THE UCMS SYSTEM AND ASSOCIATED FILES (THE “UCMS SYSTEM ”), HARDWARE (“HARDWARE”), DISK(S), CD-ROMS, OR OTHER MEDIA) (COLLECTIVELY, THE “PRODUCT”) YOU AND YOUR COMPANY ACCEPT ALL THE TERMS AND CONDITIONS OF THIS EULA. IF YOU ACQUIRE THIS PRODUCT FOR YOUR COMPANY’S USE, YOU REPRESENT THAT YOU ARE AN AUTHORIZED REPRESENTATIVE WHO HAS THE AUTHORITY TO LEGALLY BIND YOUR COMPANY TO THIS EULA. IF YOU DO NOT AGREE, DO NOT CLICK “I AGREE” AND DO NOT DOWNLOAD, SET-UP, INSTALL, UNPACK, OPEN OR USE THE UCMS SYSTEM.

- 1. Ownership.** Phoenix Technical Group LLC (“Phoenix”) and its suppliers own all right, title, and interest in and to the Universal Compliance Management System (“UCMS System”), including all intellectual property rights therein. The structure, organization, and code of the UCMS System are the valuable trade secrets and confidential information of Phoenix and its suppliers. The UCMS System is protected by copyright and other intellectual property laws and treaties, including, without limitation, the copyright laws of the United States and other countries. The term “UCMS System ” does not refer to or include “Third-Party UCMS System”. “Third-Party UCMS System” means certain UCMS System licensed by Phoenix from third parties that may be provided with the specific version of UCMS System that you have licensed. The Third-Party UCMS System is generally not governed by the terms set forth below but is subject to different terms and conditions imposed by the licensors of such Third-Party UCMS System . The terms of your use of the Third-Party UCMS System is subject to and governed by the respective license terms, except that this Section 1 and Sections 5 and 6 of this Agreement also govern your use of the Third-Party UCMS System. You may identify and view the relevant licenses and/or notices for such Third-Party UCMS System for the UCMS System you have received pursuant to this EULA at <http://phoenixtechnicalgroup.com/support-and-downloads/> . You agree to comply with terms and conditions contained in all such Third-Party UCMS System licenses with respect to the applicable Third-Party UCMS System. - 2. Product License.** Subject to your compliance with the terms of this EULA, Phoenix grants you a personal, non-exclusive, non-transferable, limited license to install and use one (1) copy of the UCMS System on one (1) device residing on your premises, internally and only for the purposes described in the associated documentation. Use of some third party UCMS System included on the CD or other media provided with the Product may be subject to terms and conditions of a separate license agreement; this license agreement may be contained in a “Read

Me” file located on the CD or other media that accompanies that Product. The UCMS System includes components that enable you to link to and use certain services provided by third parties (“Third Party Services”). Your use of the Third Party Services is subject to your agreement with the applicable third party service provider. Except as expressly stated herein, this EULA does not grant you any intellectual property rights in the Product. Phoenix and its suppliers reserve all rights not expressly granted to you. There are no implied rights.

2.1 UCMS System. You are also permitted to make a single copy of the UCMS System strictly for any or all products and product families designed by your company. You may not alter or modify the UCMS System or create a product based on the principles and design of the UCMS System. The UCMS System is sold and distributed by Phoenix, Amazon and other retailers.

3. Restrictions. You are not permitted or licensed to do any of the following:

- a. Create derivative works based on the Product or any part or component thereof, including, but not limited to, the UCMS System;
- b. Reproduce the Product, in whole or in part;
- c. Except as expressly authorized by Phoenix, to sell, assign, license, disclose, or otherwise transfer or make available the Product, in whole or in part, to any third party;
- d. Alter, translate, decompile, or attempt to reverse engineer the Product or any part of component thereof, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this contractual prohibition;
- e. Use the Product to provide services to third parties;
- f. Take any actions that would cause the UCMS System to become subject to any open source license agreement if it is not already subject to such an agreement; and
- g. Remove or alter any proprietary notices or marks on the Product.

4. Updates. If you receive an update or an upgrade to, or a new version of, any UCMS System (“Update”) you must possess a valid license to the previous version in order to use the Update. All Updates provided to you shall be subject to the terms and conditions of this EULA. If you receive an Update, you may continue to use the previous version(s) of the UCMS System in your possession, custody or control. Phoenix shall have no obligation support the previous versions of the UCMS System upon availability of an Update. Phoenix has no obligation to provide support, maintenance, Updates, or modifications under this EULA.

5. NO WARRANTY. THE PRODUCT AND THE THIRD-PARTY UCMS SYSTEM IS OFFERED ON AN “AS-IS” BASIS AND NO WARRANTY, EITHER EXPRESS OR IMPLIED, IS GIVEN. PHOENIX AND ITS SUPPLIERS EXPRESSLY DISCLAIM ALL WARRANTIES OF ANY KIND, WHETHER STATUTORY, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. PHOENIX DOES NOT PROVIDE THE THIRD PARTY SERVICES AND MAKES NO WARRANTIES WITH RESPECT TO THE THIRD PARTY SERVICES. YOUR USE OF THE THIRD PARTY SERVICES IS AT YOUR RISK.

6. EXCLUSION OF INCIDENTAL, CONSEQUENTIAL, AND CERTAIN OTHER DAMAGES. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL PHOENIX OR ITS LICENSORS OR SUPPLIERS BE LIABLE FOR ANY SPECIAL, INCIDENTAL, PUNITIVE, INDIRECT, OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROFITS OR CONFIDENTIAL OR OTHER INFORMATION, FOR BUSINESS INTERRUPTION, FOR PERSONAL INJURY, FOR LOSS OF PRIVACY, FOR FAILURE TO MEET ANY DUTY INCLUDING OF GOOD FAITH OR REASONABLE CARE, FOR NEGLIGENCE, AND FOR ANY OTHER PECUNIARY OR OTHER LOSS WHATSOEVER) ARISING OUT OF OR IN ANY WAY RELATED TO THE USE OF OR INABILITY TO USE THE PRODUCT OR ANY PART OR COMPONENT THEREOF OR RELATED SERVICE OR ANY THIRD PARTY SERVICES, OR OTHERWISE UNDER OR IN CONNECTION WITH ANY PROVISION OF THE EULA, EVEN IN THE EVENT OF THE FAULT, TORT (INCLUDING NEGLIGENCE), MISREPRESENTATION, STRICT LIABILITY, BREACH OF CONTRACT, OR BREACH OF WARRANTY OF PHOENIX OR ITS LICENSORS OR SUPPLIERS, AND EVEN IF PHOENIX OR ITS LICENSOR OR SUPPLIER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND NOTWITHSTANDING ANY FAILURE OF THE ESSENTIAL PURPOSE OF THIS AGREEMENT OR ANY REMEDY.

7. LIMITATION OF LIABILITY. NOTWITHSTANDING ANY DAMAGES THAT YOU MIGHT INCUR FOR ANY REASON WHATSOEVER, THE ENTIRE LIABILITY OF PHOENIX UNDER ANY PROVISION OF THIS EULA AND YOUR EXCLUSIVE REMEDY HEREUNDER SHALL BE LIMITED TO, AND IN NO EVENT WILL PHOENIX'S TOTAL CUMULATIVE DAMAGES EXCEED, THE FEES PAID BY LICENSEE TO PHOENIX FOR THE PRODUCT. ADDITIONALLY, IN NO EVENT SHALL PHOENIX'S LICENSORS OR SUPPLIERS BE LIABLE FOR ANY DAMAGES OF ANY KIND.

8. Indemnification. By accepting the EULA, you agree to indemnify and otherwise hold harmless Phoenix, its officers, employee, agents, subsidiaries, affiliates, and other partners from any direct, indirect, incidental, special, consequential or exemplary damages arising out of, relating to, or resulting from your use of the Product or any other matter relating to the Product, including, without limitation, use of any of the Third Party Services.

9. International Trade Compliance. The UCMS System and any related technical data made available for download under this EULA is subject to the customs and export control laws and regulations of the United States ("U.S.") and may also be subject to the customs and export laws and regulations of the country in which the download is contemplated. Further, under U.S. law, the UCMS System and any related technical data made available for download under this EULA may not be sold, leased or otherwise transferred to restricted countries, or used by a restricted end-user (as determined on any one of the U.S. government restricted parties lists, found at <http://www.bis.doc.gov/complianceandenforcement/liststocheck.htm> or an end-user engaged in activities related to weapons of mass destruction including, without limitation, activities related to designing, developing, producing or using nuclear weapons, materials, or facilities, missiles or supporting missile projects, or chemical or biological weapons. You acknowledge that you are not a citizen, national, or resident of, and are not under control of the government of Iran, North

Korea, Sudan or Syria; are not otherwise a restricted end-user as defined by U.S. export control laws; and are not engaged in proliferation activities. Further, you acknowledge that you will not download or otherwise export or re-export the UCMS System or any related technical data directly or indirectly to the above-mentioned countries or to citizens, nationals, or residents of those countries, or to any other restricted end-user or for any restricted end-use.

10. General. This EULA between Licensee and Phoenix is governed by and construed in accordance with the laws of the South Carolina without regard to conflict of laws principles. The EULA constitutes the entire agreement between Phoenix and you relating to the Product and governs your use of the Product, superseding any prior agreement between you and Phoenix relating to the subject matter hereof. If any provision of this EULA is held by a court of competent jurisdiction to be contrary to law, such provision will be changed and interpreted so as to best accomplish the objectives of the original provision to the fullest extent allowed by law and the remaining provisions of the EULA will remain in force and effect. The Product and any related technical data are provided with restricted rights. Use, duplication, or disclosure by the U.S. Government is subject to the restrictions as set forth in subparagraph (c)(1)(iii) of DFARS 252.227-7013 (The Rights in Technical Data and Computer Product) or subparagraphs (c)(1) and (2) of 48 CFR 52.227-19 (Commercial Computer Product - Restricted Rights), as applicable. The manufacturer is Phoenix. You may not transfer or assign this EULA or any rights under this EULA, except that you may make a one-time, permanent transfer of the UCMS System populated with data for a product which a National or International party (e.g. an EU Enforcement Officer has requested a Technical File for your product.

Future Software Implementations of the UCMS System will provide a READ-ONLY Portal for this express purpose.

You shall affix a copy of this Copyright / License agreement to the front of every physical (hardcopy) folder and to any and all outputs provided to National or International agencies to identify the UCMS as a licensed / copyright protected product of Phoenix.

Any attempted assignment in violation of this Section is void. Phoenix, the Phoenix logo, and other Phoenix names and logos are the trademarks of Phoenix.

11. Arbitration. All claims and disputes arising under or relating to this Agreement are to be settled by binding arbitration in the state of South Carolina. The arbitration shall be conducted on a confidential basis pursuant to the Commercial Arbitration Rules of the American Arbitration Association. Any decision or award as a result of any such arbitration proceeding shall be in writing and shall provide an explanation for all conclusions of law and fact and shall include the assessment of costs, expenses, and reasonable attorneys' fees. Any such arbitration shall be conducted by an arbitrator experienced in software industry and shall include a written record of the arbitration hearing. The parties reserve the right to object to any individual who shall be employed by or affiliated with a competing organization or entity. .
